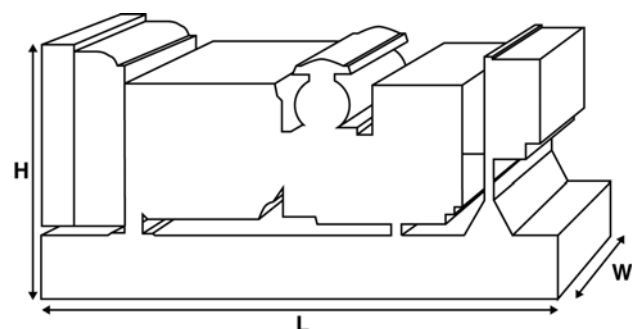
Standby Rating
